"When I turned 13 I'd had enough of the abuse in the home and I ran away. I didn't know where to go so I went to the center of town and stood by the town hall. A man saw me hanging around there and he said that he was looking for a 'protégé.' I didn't know what it was but it sounded fine to me. He said that I could stay at his house if I didn't have a place to stay... When we got to his house he pulled out a bottle of gin and had me drink and drink. The next thing I remember is waking up drunk in his bed all wet and hurt. He took me out on the street and told me what to do... During that time I saw 10 to 20 men a day. I did what he said because he got violent when I sassed him. I took all kinds of drugs—even though I didn't really like most of them... Over the years I had pimps and customers who hit me, punched me, kicked me, beat me, slashed me with a razor. I had forced unprotected sex and got pregnant three times and had two abortions at [a clinic]. Afterward, I was back on the street again. I have so many scars all over my body and so many injuries and so many illnesses. I have hepatitis C and stomach and back pain and a lot of psychological issues. I tried to commit suicide several times"


- a) Sex trafficking in which a commercial sex act is induced by force, fraud, or coercion, or in which the person induced to perform such act has not attained 18 years of age; or
- b) The recruitment, harboring, transportation, provision, or obtaining of a person for labor or services, through the use of force, fraud, or coercion for the purpose of subjection to involuntary servitude, peonage, debt bondage, or slavery. (22 U.S.C. § 7102(9)).

Human trafficking is a crime.

Labor Trafficking:

- Happens to kids and adults
- Includes US Citizens and immigrants
- Hidden in plain sight...
- Includes large and small operations
- Is unpaid and / or forced labor often in dangerous conditions
- Debt bondage workers need to pay off an overwhelming initial debt to the traffickers – passports or paperwork may be held by the traffickers
- Occurs in Colorado
 - Agriculture
 - Personal care (nail salons, massage, etc)
 - Hospitality
 - Construction
 - Begging/panhandling
 - Domestic work / home care / child-care

- Hussein Abdi Kahin was a 4 year old boy who fled Somaliland with his family after his father was killed during the war
- Separated from his mother and brother and sent to live with his uncle in Djibouti
- 8 or 9 years of age brought to the UK under the name of another child. He was brought by a woman who was said to be a "family friend".
- Thought he was going to live with family in the UK and had their contact information on a piece of paper.
- The woman took the paper threw it away, told him his name was changed.
- Forced to work for the woman \rightarrow clean, cook, care for their children (he was a child....)
- Finally allowed to attend school at the age of 12
- A track coach took him under his wing and helped him find a foster family
- Eventually he became a decorated long-distance runner and Olympic Gold medalist.
- He kept quiet about his childhood trafficking because he worried he'd be deported.

Sexual trafficking:

• The recruitment, harboring, provision or obtaining of a person for sex acts through the use of force, fraud or coercion


Commercial Sexual Exploitation of Children is CHILD ABUSE:

 Any person <u>under 18 years of age</u> who has been subject to sexual exploitation as a result of their loitering for the purpose of prostitution or their engagement in an offer to exchange sexual conduct in return for food, clothing, a place to stay, drugs, or a fee


There is no such thing as a child prostitutethey are abused and exploited children.

RECRUITER RELATIONSHIP ADULTS AND CHILDREN




MEANS OF CONTROL USED ON CHILDREN

Sex trafficking is more profitable than illegal drugs


Labor trafficking provides cheap labor without safety restrictions

Trafficking happens in Colorado

- In 2016-2020: 149 cases of child trafficking reported in CO
- 12% of high-risk teens (12-17 years old) screened in a pediatric ED in Denver were found to be likely victims of human trafficking
- 88% of people who are trafficked visit a medical facility during their time of being exploited
- An estimated 150,000-300,000 children in the US are at risk for commercial sexual exploitation each year

People who are being trafficked DO present to medical care....

- 80% of people who have been trafficked were seen by a medical provider within the first 6 months of being trafficked!
- The trafficker will often accompany the victim, and may be
 - Male or Female
 - Present as family member or friend
 - Appear caring, parental, sympathetic
 - Well spoken
 - Reluctant to leave the patient alone
- Patient may refer to pimp as "boyfriend", "aunt", "uncle", "mom", "daddy"
